Medication Name	Xanax (Alprazolam)
Drug Class	Benzodiazepine
Prescription Status	Prescription-only
Primary Purpose	Anxiety & panic disorder management

## 2 WHAT XANAX IS & HOW IT WORKS

Topic	Explanation
Mechanism	Enhances GABA activity in the brain
Result	Produces calming and relaxing effects 
Onset Time	Usually within 30–60 minutes
Duration	Several hours depending on dose
Important Note	Individual response varies

---

## 3 MEDICAL USES

Condition	Purpose
Generalized Anxiety Disorder	Reduces excessive worry
Panic Disorder	Controls sudden panic attacks
Short-Term Stress Reactions	Temporary symptom relief
Adjunct Therapy	Combined with psychotherapy

Step	Description
Online Intake Form	Patient provides medical history
Virtual Consultation	Video or phone visit with clinician
Clinical Evaluation	Determines if medication is appropriate
Prescription Issued	If medically justified

Pharmacy Fulfillment	Licensed pharmacy dispenses medication
Home Delivery	Medication shipped securely 📦

Medical Review	Ensures appropriateness
Dosage Control	Prevents misuse
Drug Interaction Check	Avoids harmful combinations
Follow-Up Visits	Monitors effectiveness
Patient Education	Encourages safe use

Rule	Why
Take as Prescribed	Avoids misuse
No Alcohol	Prevents respiratory depression
Do Not Share	Legal & safety risk
Store Safely	Prevents accidental ingestion

Factor	Best Practice

Temperature	Room temperature
Container	Original bottle
Access	Out of reach of children
Disposal	Pharmacy take-back
